If your barn is bringing 10+ horses, please complete multiple forms. All horse entries must be current with the show office at the time this form is submitted.

Throughout the stay, please minimize horse-to-horse contact and follow all biosecurity measures noted below. Early identification is crucial when dealing with disease outbreaks, and this requires cooperation from everyone within the community.

- Complete and record temperatures twice-daily on the provided log kept visibly posted at your barn
- Monitor horses frequently for signs of disease throughout stay
- Immediately report any horses with elevated temperatures or symptoms to Paso Park management
- Limit horse-to-horse contact
- Limit horse-to-human-to-horse contact
- No grazing horses

- Avoid submerging the end of water hoses in water buckets
- All dogs at the Paso Robles Horse Park facility must be kept on a leash and should have no contact with horses
- Avoid sharing of equipment including tack, buckets and brushes; if equipment is to be shared it must be thoroughly scrubbed between horses
- Horses should have labeled dedicated water and grain buckets to avoid exchanging of this equipment amongst horses
- Do not allow horses to drink directly from water hose

Please initial to confirm or answer the following questions for EVERY horse noted in the above list. Seven days prior to arrival at the Paso Robles Horse Park.

#1 _____ I confirm each horse has current vaccines for influenza and EHV. Please see below for required vaccine format and submission details.

#2 _____ I confirm each horse above will have temperatures monitored twice daily for the three (3) days prior to arrival at the Paso Park. If a temperature above 101.5 degrees F is detected, that horse will not be brought to the Paso Robles Horse Park.

#3 _____ I confirm each horse has been in good health and had no signs of respiratory distress or neurological symptoms in the seven (7) days prior to arrival at the Paso Park.

All of the above noted horses entering the Paso Robles Horse Park are currently healthy and have not displayed a temperature of over 101.5 degrees F in the three (3) days prior to entering the Paso Robles Horse Park. Additionally, these horses' temperatures have been monitored twice daily for three (3) days and a [Temperature Log](#) will be provided to Paso Park management at the time of arrival. Throughout showing at the Paso Robles Horse Park all horses' temperatures and overall health will continue to be monitored.

All vaccine records must be submitted on veterinary letterhead and signed by a licensed veterinarian or organized using the [USEF Vaccination Form](#). Submitted information must clearly indicate each horse attending the show by show name and the dates vaccines were administered. Please note that to be current and active, the EVH-1 vaccine must have been received within the following dates OR are on a regular 6-month schedule:

Fall Fun Schooling Show (4/7/22 - 9/23/22)

Pumpkins & Ponies (4/12/22 - 9/29/22)

Fall Classic (5/1/22 - 10/19/22)

Oaktree Classic (5/8/22 - 10/26/22)

Turkey Trot & Jump (5/17/22 - 11/3/22)

At any time throughout this show horses are subject to examination by Paso Park designated representatives and/or State Animal Health officials. If after such examination it is believed the health condition of a horse will place other animals at risk, the horse and others that have been infected/exposed may be isolated in the designated on-site isolation locations, or, if necessary, require removal of the animal from the facility.

I take full responsibility to report immediately a temperature above 101.5 degrees F or any signs of respiratory distress or neurological disease to the Park management by texting or calling 805-369-1338. The on-call veterinarian is Dr. David Bogenrief, DVM 805-441-2435.

In recognition of the potential exposure risk attending any competition poses, and in an effort to support minimizing the risk to horses at home facilities and those that are onsite at the Paso Robles Horse Park, we are

asking every barn to identify their quarantine arrangements should there be an exposure during the competitions held at the Paso Robles Horse Park.
