



# ***2026 Stall Reservation Policy for Paso Park-Managed Horse Shows***

Stall requests can be made by trainers or by independent riders. By completing the online form, texting 805-369-1323 or emailing [stalls@pasorobleshorsepark.com](mailto:stalls@pasorobleshorsepark.com) to request stalls, you acknowledge that you accept the full financial responsibility of the reservations you make on your behalf individually, or on the behalf of yourself and your training clients. We strongly advise that initial reservations be completed on the stall reservation form at [pasorobleshorsepark.com/stall-reservations/](https://pasorobleshorsepark.com/stall-reservations/). Updates can be made to your reservation at any point prior to the stall confirmation deadline by texting 805-369-1323 or by emailing [stalls@pasorobleshorsepark.com](mailto:stalls@pasorobleshorsepark.com).

As soon as possible, you will be notified by Park staff if your reservation can be accommodated or if you are on a waitlist for that show. The following outlines your financial commitment and fees related to stall reservations:

- Prior to the posted [Closing Date](#): No financial penalties for reducing or canceling your total stall reservation.
- After entry [Closing Date](#): You are financially responsible for the full cost of the total number of stalls most recently requested and a \$50 office fee per stall reserved.

In the case that there are still stalls available after the related Closing Date of a horse show, late reservations may be made by texting 805-369-1323 or by emailing [stalls@pasorobleshorsepark.com](mailto:stalls@pasorobleshorsepark.com). All late reservations must include a firm stall count and will have 48 hours after sending that count to make final adjustments, after that point you will fall into the financial commitments outlined above.

If your stall needs to change after that deadline you may work with other trainers to take those stalls, HOWEVER:

- Exchanges of stalls between trainers must be communicated to the Paso Park staff in writing for final approval and must include both trainers on the communication.
- Any exchanges made between trainers less than 10 days before the start of the show may not be accounted for in the stall chart.
- If there is any misunderstanding between trainers as to who is responsible for the stall cost, it will be the trainer that had them originally reserved that is ultimately financially responsible for the stalls.

If something does change please don't hesitate to reach out to us as soon as possible. In the case of a serious medical incident, a doctor's note or veterinarian's note received via email at least 48 hours in advance of the first day of scheduled competition will result in waiving the stall fees; however, the \$50 office fee will still be due. The above language outlines the policy we follow, but with advanced notice, we will always try to work with trainers as best we can while maintaining a fair approach for all competitors.

In the case that you will no longer be able to attend the horse show, please refer to the chart below to determine if you owe any outstanding fees or will be receiving any refunds.

We appreciate your efforts to help us be organized in preparing for the shows and allowing us to accommodate as many competitors as possible. Should an unforeseen circumstance arise, please do not hesitate to reach out to management to discuss the details and determine if an exception can be made.

# CLASS SPECS

## Q = GREAT AMERICAN INSURANCE/USDF QUALIFYING.

To qualify for the 2026 Great American Insurance Group/USDF Regional Dressage Championships, horse/rider combinations must earn two qualifying scores at two different USEF-licensed/USDF-recognized competitions with different judges. Qualifying classes must be at Test 3 for most levels, with specific minimum scores required for Open, Adult Amateur (AA), and Junior/Young Rider (Jr/YR). Add \$20 to class fee and review membership and horse registration requirements prior to entering. Horse may enter two consecutive levels only – even if more than one rider. Horse limited to three tests per day (Intro-3rd).

- Minimum Scores (Test 3):
  - Training Level: 68% (Open), 63% (AA/Jr/YR).
  - First Level: 66% (Open), 62% (AA/Jr/YR).
  - Second Level: 64% (Open), 61% (AA/Jr/YR).
  - Third/Fourth Level & FEI: 62% (Open), 60% (AA/Jr/YR).
  - Freestyle Scores: 65% minimum for all levels and divisions.

## FREESTYLE

Dressage musical freestyle is an exciting combination of the technical and artistic aspects of classical dressage. To foster the highest possible technical quality in freestyle performances, competitors are required to enter a freestyle class only at the level at which they have already demonstrated proficiency. A copy of the USDF score verification verifying eligibility, must be submitted with the entry for a freestyle class. Qualification of those entries will be verified by USDF. Riders receiving scores within 30 days prior to a competition may submit a copy of the test verifying eligibility. Refer to USEF Rules, DR 129.9 for details on equivalencies

### General

Musical freestyle is an artistic program created by the rider to present his or her horse to its best advantage in an artistic, musical context.

- It is judged according to technical execution (execution of compulsory movements) and artistic impression (harmony, choreography, degree of difficulty, music, and interpretation).
- It is performed in a standard dressage arena (20 x 60 meters).
- A copy of the program is not submitted in advance.

## FREESTYLE CONT.

- It is the responsibility of the rider to remember and execute the choreography. Should disobedience or some other issue cause a disruption in the patterns, it is the rider's responsibility to get back on course.

- Current USDF scoresheets must be used.

### Time

- The maximum time limit for all USDF freestyles is five minutes. There is no minimum time requirement.
- The bell or whistle will not be sounded at the end of five minutes.
- Movements performed after the time limit has elapsed will not be scored. One (1) point will be deducted from the total for artistic impression for exceeding the time limit. A 10-second grace period should be given before a deduction is taken.
- The program is timed from the horse's move-off after the initial halt and salute and ceases at the final salute.
- The rider must signal the sound engineer within 45 seconds of the entry bell or be eliminated. The rider must enter the arena within 30 seconds of the start of the music, or they may be eliminated at the discretion of the Judge.
- Exceeding 75 seconds before entering the arena after the bell has sounded will entail elimination.

### Music

- Music is mandatory.
- Exit music is not allowed.
- The music must cease at the final salute.
- DR 129: In case of rider's music failing before or during a Freestyle Test and in cases where there is no backup system, the rider can, with permission of the judge at "C", leave the arena or start at a later time. There should be minimum interference with the starting times of the other riders and the affected rider should return to complete or restart his/her test during a scheduled break in the competition or at the end of the competition. The rider may decide

# CLASS SPECS

## DRESSAGE SEAT EQUITATION

- Gaits shall be performed by the exhibitors simultaneously.
- Medium walk, working trot, and working canter both ways of the ring must be performed. Equitation classes may also be offered that are limited to medium walk and working trot; these walk-trot classes are not qualifying classes for the USDF Dressage Seat Medal Semi-Finals or Regional AA Finals.
- Riders must be judged at the medium walk, sitting and rising working trot, and working canter in both directions. When rising trot is requested, the rider should change the diagonal when changing directions, except during a lengthening. The correct diagonal is considered to be when the rider is sitting when the outside front foot and inside hind foot are on the ground.
- USEF DR133.4-6 states that, in judging the position, seat and use of aids, judges may include the following movements and exercises as required at Training and First Level and they may be ridden as a group:
  - o Free walk
  - o Transitions from one gait to the next in both directions
  - o Transitions from walk to halt and vice versa
  - o Change of direction across the diagonal, down the centerline, across the arena, and/or by making a half-circle at the walk or trot.
- Judges may also choose movements and exercises, as required at Training and First Level, to be ridden in small groups or independently:
  - o Leg yield
  - o Changes of lead through trot
  - o Serpentine at the trot
  - o Shallow loop serpentine in canter, maintaining lead
  - o Trot lengthening and/or canter lengthening.
- Individual workout patterns are not recommended for regular DSE classes, but if used, a copy of all workout patterns, selected in advance by the judge(s), should be posted and distributed to all riders entered in the DSE class(es) at least one day prior to the class. All workout patterns require the use of a dressage arena or letters set up within an open ring.

## MATERIALE

Horses will be evaluated under saddle at the walk, trot and canter in both directions of the arena. In addition, four and five year old horses may be asked to lengthen the stride at the trot and canter. If necessary, classes can be combined as follows: Three-year old fillies may be shown with four and five-year old mares, and three-year old colts and geldings may be shown with four and five-year old stallions and geldings. However, classes for fillies and mares may NOT be combined with classes for colts, geldings or stallions, and horses may NOT be asked to lengthen stride at trot or canter when three-year olds are shown together with older horses. Depending on local conditions, Materiale classes may be divided at the judge's discretion, All horses must compete together as a group in Materiale classes. Riders in any Materiale class are permitted to ride only one horse per class, including classes divided for judging purposes per USEF DR209.3. Horses must be at least 36 months of age to participate in Materiale classes. Mares may not compete under saddle or in Materiale classes after their eighth month of pregnancy or within three months after foaling. Unauthorized assistance by individuals outside the competition ring is not permitted. Horses will be evaluated according to the criteria listed on the "USDF Materiale Class" Scoresheet, and classes must be conducted according to the USDF "Procedures to Host USDF DSHB Materiale Classes".

## OPPORTUNITY CLASSES

Horse, owner, rider, trainer and coach do not have to be USEF, USDF or CDS members and do not have to pay non-member fees. Opportunity classes are not eligible for USEF/USDF End of Year Awards Programs. Opportunity classes do count toward CDS Qualifying, CDS End of Year Awards, CDS RAAC Qualifying and Junior Championships, as long as CDS membership of rider and owner is current at the time that scores are earned. Horse and/or riders entered into opportunity classes may cross enter into the rated/recognized classes, but must then meet all membership requirements.

## **No Same Day Adds**

Unless otherwise approved by Horse Show Management, same day adds are not permitted.

## **Horse Numbers**

Horses must wear their numbers at all times when out of their stalls and be visible for stewards and technical delegates.

## **Scored Tests**

Scored tests will be given only to riders or their agents and only after the results are finalized and the class is placed. Any disputes concerning scores, divisions entered (AA, JR/YR, Open), and/or placings must be brought to the attention of the Show Office within one hour of the end of the show day. Scores and placings become final at that time. Tests not picked up will be discarded. A self addressed stamped envelope is required for a test to be mailed.

## **Hunter/Jumper & Dressage Entries**

Horses cannot compete in two competitions on the same day per DR119.2. If horses enter hunter/jumper classes on days they are not competing in dressage, they are subject to all membership and show fees for both competitions. Horses will have separate entry numbers and must check-in and check-out for each show separately.



# RULES & REGULATIONS

## COMPETITION

» **AWARDS** - Ribbons through 5th place. First place awards to classes with three or more entries. High point awards will be presented to the junior, open and adult amateur riders each day. High Point awards exclude opportunity, introductory, materiale and freestyles rides.

» **HELMETS** – Per GR801 All professionals and non-professionals riding on Paso Park property must wear securely fastened protective headgear, which meets ASTM/SEI standards and carries the SEI tag. Any rider violating this rule at any time will immediately be prohibited from further riding until such headgear is properly in place.

» **MUSICAL FREESTYLES AND SOUND CHECKS** – Sound checks for musical freestyles will be conducted at 7:30 AM each morning at the show arena. All Freestyle entries Training-Fourth Level must submit proof of at least a 63% at the highest class of the level and all FEI at least a 60%. Music must be submitted no later than 5 PM the day prior to the scheduled ride to the Show Secretary via email ([dressage@pasorobleshorsepark.com](mailto:dressage@pasorobleshorsepark.com)).

» **SAFE SPORT** - All USEF Life and Senior Active members, as well as participants who have regular contact with minor athletes, are required to comply with the U.S. Center for SafeSport training requirement to be eligible to participate in the competition. All participants must adhere to the U.S. Center for SafeSport Code, USEF Safe Sport Policy, and the Minor Athlete Abuse Prevention Policies. More information about these can be found at [www.usef.org](http://www.usef.org).

» **TACK INSPECTIONS** - Exhibitors must present bridles and bits, if and when requested, to the technical delegate for inspection utilizing the methods, timeframe(s) and location(s) identified by competition management with the agreement of the technical delegate. These methods must be communicated to the competitors prior to the start of the competition. The technical delegate must inspect at least 50% of the bits and bridles of horses entered in the competition. Technical Delegates must also conduct random ringside bit checks immediately after rides are completed, some of which can be included in the 50%, using a new disposable protective glove on each hand for each horse. When non-permitted bits, saddlery, or equipment are identified prior to the horse having worn the non-permitted items, there will be no elimination. Elimination will occur only when the horse is wearing non-permitted items or they are identified immediately after use.



# RULES & REGULATIONS (CONT.)

## FACILITY

- » **ARENAS** - All arenas at the Paso Robles Horse Park contain premier GGT Footing. The show and warm-up arenas measure as follows:
  - > Fairway Grand Prix Arena: 250' x 345'
  - > LD Hayes Grand Hunter Arena: 190' x 260'
  - > Butterfield Arena: 150' x 275'
  - > JW Arena: 150' x 275'
  - > Oak Grove Arena: 140' x 255'
  - > Warm-Up Arenas #1 & #2: 140' x 230'
  - > Grand Prix Warm-Up: 150' x 275'
  - > Warm-Up Arena #3: 150' x 275'
  - > Warm-Up Arena #4: 130' x 220'
- » **CELL PHONES** - Active use of cell phones and all cellular transmission devices is not permitted in any competition or warm-up arena.
- » **DOGS** - All dogs at the Paso Robles Horse Park must be on a leash or tied at all times. There will be a \$50 penalty for any dogs off-leash or owners who do not pick up after their dogs.
- » **EMERGENCY CARE** – Twin Cities Community Hospital Emergency Room is 11 miles away from the Paso Park at 1100 Las Tablas Road, Templeton, CA 93465.
- » **LEVEL 1 TRAUMA CENTER** – Community Regional Medical Center is 109 miles away from the Paso Park at 2823 Fresno Street, Fresno, CA93721.
- » **LUNGING** – Lunging is only permitted in the two designated lunging arenas. There is no mounted riding or schooling of any sort of jumps permitted in the lunging arenas. There is a \$500 fine for lunging in non-designated arenas. Footing in these areas is comprised of mesa sand footing.
- » **MEDICAL WASTE** – In accordance with the 1989 Federal Waste Tracking Act, which restricts the disposal of medical waste, bio-hazardous medical waste containers will be provided in the stable area. All exhibitors and their agents are responsible for the proper disposal of this waste.
- » **NON-SMOKING FACILITY** – Please refrain from smoking or use of any vape products while on the facility.
- » **PARK SAFETY & SURVEILLANCE** – In an effort to protect horses, competitors and the safety of the Paso Park, certain areas of the facility are under video/sound/photo surveillance. By competing at or attending competitions at the Paso Robles Horse Park you authorize any surveillance of your activities while on the premises. The Paso Robles Horse Park is responsible for the management of the surveillance system and has exclusive control of the release of video/audio/images.
- » **PHOTO & VIDEO CONSENT** – By competing at or attending competitions or events at the Paso Robles Horse Park, you grant permission to unrestricted rights to use photographs and/or video footage of you, your horse, your pets, your family, and/or your guests for the purpose of promotion of the Paso Park in various mediums.
- » **PRIVATE FACILITY** – This is a privately owned and operated facility. Any horse on the grounds must be associated with and entered into the current competition taking place. Cases of exception, including utilizing the facility to transfer shipping horses, must be approved through the management.

» **SHARPS** - Sharps containers are located on the backside of every barn building. They are checked and emptied regularly.

» **STALLS** - Stalls on-site are 12' x 12' with Dutch doors. Stalls have rubber mat flooring. Each stall has access to electricity and there are four water spickets in each stall aisle. Due to the unpredictable nature of the industry, stall assignments aren't finalized until 72 hours before the first day of competition. We do our best to accommodate all requests, but are constrained by various factors. Stalls are assigned based on previous attendance at Paso Park-managed shows, sponsorships, barn size, and our ability to maximize the use of these stalls.

» **TRAILER PARKING** – All trailers must be parked in the designated trailer parking lot near the entrance of the Park. Any trailer not parked in the correct location may be booted and applicable to a \$50 fee.

## SHOW OFFICE

» **DISCREPANCIES and/or BILLING ERRORS** – The show office is open and available until the completion of the last class on Sunday. If after “closing out” with the office a billing discrepancy is noted, competitors have 72 hours after the end of the show to send email communication to [office@pasorobleshorsepark.com](mailto:office@pasorobleshorsepark.com). After that point, all billing is final.

» **ENTRIES MADE AT THE SHOW** – Entries made the Tuesday of the show week or later during the show will incur a \$150 office fee.

» **FEED, SHAVINGS, AND GRAIN** – The Paso Robles Horse Park Feed Office will be open during show dates and will be offering hay, shavings, and grain feed. For advance orders please email [feed@PasoRoblesHorsePark.com](mailto:feed@PasoRoblesHorsePark.com) or complete the online feed form. Orders can also be made at the show in the office. Please note there will be no same day grain deliveries. Competitors may bring their own feed and bedding but they may not receive a feed or bedding delivery from an outside company.

» **LATE FEES** – Entries received after Closing Day will be charged a \$75 office fee. Entries made after 8a.m of the day prior to ticketed warm-ups will be charged a \$100 office fee. » **MAILED ENTRIES** - All entries must be postmarked by Entry Closing deadlines noted on page 4 with all required numbers and signatures to receive early entry status.

» **NON-COMPETING HORSES** – All horses on the grounds must be entered to compete in classes. If you are not planning to show, a \$150 non-competing fee will apply. All horses on the grounds will be assigned a number. To be considered a competing horse an entry must be shown in judged classes.

» **OFFICE FEE** – A fee of \$75 will be charged to each horse/rider combo for the week of competition. This is the only per horse fee and it includes medical personnel and emergency response, entry software, security, horse health, and office support.

» **OPEN BALANCES** – Competitors who do not come into the office to close out at the end of the show forfeit the right to adjustments on any show charges. Final balances will be automatically charged to the payment method on file. Competitors who fail to submit a valid form of payment for the full amount of their show bill by 5 p.m. on Sunday of the show week, will be charged a \$50 office fee.

## RULES & REGULATIONS (CONT.)

» **PAST CREDITS/BALANCES** – Competitors may be notified of any previous Paso Park activity at the time of check-in. Outstanding balances must be paid prior to picking up show numbers. Outstanding balances may be deducted from prize money payments. Unpaid balances may prevent a competitor and/or their trainer of record from having stall reservations accepted. If a balance remains unpaid for more than 30 days the office may require a \$1,000 deposit payment before processing future entries.

» **PAYMENT** – All payments should be paid by credit card, cash, or check made payable to Paso Robles Horse Park Foundation. Any checks returned by the bank will be charged a \$100 penalty or 10% of the face value of the check, whichever is greater. Payments made by check or cash will receive a \$10 voucher for credit towards Paso Park Merchandise. No credit card fees are charged. Competitors that fail to submit a valid form of payment for the full amount of their show bill by 5pm on Sunday of the show week will be charged a \$50 office fee.

» **REFUNDS** – Past the closing dates on page 5, but at least 48 hours in advance of the first day of competition show scratches will require a note from either a doctor or veterinarian explaining the reason the competitor or horse cannot compete, acceptable at management's discretion. A competitor may replace one entry with another horse. If no replacement is made or note is received, competitors are responsible for the full stall fees and a \$50 office fee. Stalls are non-refundable. In all cases, a \$50 office charge will still be applicable.

» **SHOW SCRATCHES** – Up until the Entry Closing date you may make changes to or cancel your entries and related stall reservations. After that point you are fully responsible for the stall fee related to each specific horse's entry and for a \$50 office fee. At management's discretion, entry fees will be refunded in full, less a \$50 office charge, with veterinary certificate or medical doctor's note submitted via email at least 48 hours prior to the start of the show's first judged class. For more information on refunds and show scratches, refer to page 7 of this prize list.

» **TEMPERATURES** - Any horse exhibiting a temperature over 101.5F must be reported to management immediately.

» **TEXT ALERTS** – All trainers will be automatically enrolled in text updates utilizing the contact information submitted with entries or stall reservations. At the start of the show there will be an introductory text that allows the opportunity to opt-out.

» **TRAINER SPLITS** – Trainers may choose to add tack/grooming, feed and bedding orders, RV reservations, competitor show expenses, or any other miscellaneous show purchases to their "trainer splits." Trainers have until 5 p.m. on Friday of the show to complete the trainer split form indicating which competitor accounts to apply the division of expenses to and how to apply the division. If they do not complete this form by the deadline, the office may charge the full amount to the trainer's payment on file. It is fully and solely the trainer's responsibility to indicate what items are applicable to the split and how it should be applied. By completing and submitting your entry form with the indicated trainer's name on it, you accept the responsibility to be financially responsible for any assigned splits from that trainer for all costs related to the show you are entering. The horse show management is not able to intervene in a trainer's direction of how to assign those expenses.

» **VACCINATIONS AND HORSE HEALTH** - Per GR845 Equine Vaccination Rule: At Federation licensed competitions, horses entering the grounds must be accompanied by documentation of Equine Influenza Virus and Equine Herpes Virus (Rhinopneumonitis) vaccinations within six months prior to entering the stables. Horses not in compliance with this rule may be required to leave the competition grounds upon request by Competition Management. Competitors may be asked to provide proof of vaccination upon check-in or prior to entering the property.

### DISCLAIMERS

» Every horse entered for competition will comply with the rules of the horse show management, but management will, in no case, be responsible for any loss or damage that may occur, and it shall be condition of entry that each exhibitor shall hold this horse show, the officials, contractors, and employees of the show blameless for any loss or accident to his/her/their horse, employees, equipment, which may occur from sickness, fire, or otherwise.

» The management reserves the right to refuse, accept conditionally, or to cancel any entries, disqualify any riders or exhibitors, prohibit entries, and cancel award prizes without claims for damages; to cancel or combine unfilled classes, or to reschedule classes after due notice to exhibitors; to change rings or rotate judges.

» Exhibitors are notified that any act of discourtesy or disobedience to the management, judges, or officials, on the part of the owner, trainer, manager, rider, or groom shall disqualify the horse, and the owner shall forfeit entry fee and other fees.

» Show management reserves to itself the power to prohibit any person from attending or showing a horse in the ring and to remove any trainer, competitor, groom, or horse from the show without being liable for compensation.

» All questions not covered in these rules and regulations shall be decided by the show management whose decision shall be final.

» **EVERY CLASS OFFERED HEREIN WHICH IS COVERED BY THE RULES AND SPECIFICATIONS OF THE CURRENT USEF RULE BOOK WILL BE CONDUCTED AND JUDGED IN ACCORDANCE THEREWITH.**

## MEMBERSHIP STATEMENT

Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Modified Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A non-member may participate as a handler, rider, driver, owner, lessee, or agent at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) assistant handlers in Dressage Sport Horse Breeding classes.

## MOTORIZED VEHICLE STATEMENT

Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

**1. Consideration & Acknowledgment of Risk.** In consideration for being permitted to participate in equestrian activities, including but not limited to competitions, training, riding, handling, and any related events at the Park, I, the undersigned, acknowledge and agree as follows:

a. I understand and acknowledge that equestrian activities are inherently dangerous and involve significant risks of serious bodily injury, illness (including communicable diseases), permanent disability, paralysis, or death to myself, my horse(s), and others. I further acknowledge that these risks include, but are not limited to, falls, collisions, unpredictable animal behavior, equipment failure, and the negligence of other participants, spectators, and event organizers.

b. I represent that I have the necessary training, experience, and physical ability to participate safely and that I will comply with all rules and regulations of the Paso Robles Horse Park Foundation (the "Foundation"), Paso Robles Horse Park, LLC ("PHRP"), and any governing equestrian bodies.

**2. Waiver and Release of Liability.** To the fullest extent permitted by law, I voluntarily release, waive, and discharge the Park, the Foundation, PHRP, and their respective officers, directors, managers, employees, agents, volunteers, affiliated organizations, insurers, sponsors, and vendors (collectively, the "Released Parties") from any and all claims, demands, causes of action, liabilities, costs, or expenses, including attorney's fees, arising out of or related to any injury, death, or property damage that I, my horse(s), or my guests may suffer while at the Park, whether caused by the negligence of the Released Parties or otherwise.

**3. Express Assumption of Risk.** I voluntarily assume all risks of injury or death for myself and my horse(s), and for property damage associated with my participation in equestrian activities at the Park, including risks that may arise from the negligence of the Released Parties.

**4. Indemnification and Hold Harmless.** I agree to indemnify, defend, and hold harmless the Released Parties from any claims, damages, liabilities, costs, or expenses (including attorney's fees) arising from:

- a. Any injury, death, or property damage caused by me or my horse(s) while at the Park;
- b. Any claims brought by third parties against the Released Parties due to my actions or the actions of my horse(s); and
- c. Any failure on my part to comply with Park rules or applicable regulations.

**5. Waiver of Unknown Claims (California Civil Code § 1542).** I expressly waive any rights under **California Civil Code § 1542**, which states:

*"A general release does not extend to claims that the creditor or releasing party does not know or suspect to exist in his or her favor at the time of executing the release and that, if known by him or her, would have materially affected his or her settlement with the debtor or released party."*

I acknowledge that I understand the significance of this waiver and that I am giving up any potential future claims that I may not presently be aware of.

**6. Scope & Binding Effect.** This agreement is binding upon me, my heirs, assigns, legal representatives, and any minors for whom I am signing as a parent or legal guardian. If any provision of this agreement is held invalid, the remainder shall remain in full force and effect.

**7. Governing Law & Jurisdiction.** This agreement shall be governed by and construed under the laws of the State of California. Any disputes arising under this agreement shall be resolved exclusively in the state or federal courts located in San Luis Obispo County, California.

For and in consideration of United States Equestrian Federation, Inc. dba US Equestrian ("USEF") allowing me, the undersigned, to participate in any capacity (including as a rider, driver, handler, vaultor, longeur, lessee, owner, agent, coach, official, trainer or volunteer) in a USEF sanctioned, licensed or approved event or activity, including but not limited to equestrian clinics, practices, shows, competitions and related or incidental activities and ("USEF Event" or "USEF Events"), I, for myself, and on behalf of my spouse, children, heirs and next of kin, and any legal and personal representatives, executors, administrators, successors,, and assigns, hereby agree to and make the following contractual representations pursuant to this Agreement (the "Agreement"):

**A. RULES AND REGULATIONS:** I hereby agree that I have read, understand, and agree to be bound by all applicable Federation Bylaws, rules, and policies including the USEF Safe Sport Policy and Minor Athlete Abuse Prevention Policies (MAAPP) as published at [www.usef.org](http://www.usef.org), as amended from time to time.

**B. ACKNOWLEDGMENT OF RISK:** I knowingly, willingly, and voluntarily acknowledge the inherent risks associated with the sport of equestrian and know that horseback riding and related equestrian activities are inherently dangerous, and that participation in any USEF Event involves risks and dangers including, without limitation, the potential for serious bodily injury (including broken bones, head or neck injuries), sickness and disease (including communicable diseases), trauma, pain & suffering, permanent disability, paralysis and death; loss of or damage to personal property (including my mount & equipment) arising out of the unpredictable behavior of horses; exposure to extreme conditions and circumstances; accidents involving other participants, event staff, volunteers or spectators; contact or collision with other participants and horses, natural or manmade objects; adverse weather conditions; facilities issues and premises conditions; failure of protective equipment (including helmets); inadequate safety measures; participants of varying skill levels; situations beyond the immediate control of the USEF Event organizers and competition management; and other undefined, not readily foreseeable and presently unknown risks and dangers ("Risks").

**Membership Requirements for USEF-licensed/USDF-recognized Competitions:** Owners and riders, including foreign riders and owners who are not residents of the US, wishing to participate in a USEF-licensed/USDF-recognized competition as a rider or owner/lessee, must have either a USDF Group Membership (GM), Participating Membership (PM), or have a USDF Non-Member (NM) identification number and pay the USDF Non-Member (NM) fee. (Note: USDF Business Members can own horses but cannot compete as riders with their USDF Business Membership.)

Horses competing at USEF-licensed/USDF-recognized competitions must have either a USDF Horse Identification (HID) number or a USDF Lifetime Horse Registration (LHR). Proper credentials or verification certificates must be presented to the competition secretary.

Riders and owners wishing to participate in a USEF-licensed/USDF-recognized competition, and not able to present the competition secretary with verification of a USDF membership or NM identification, and USDF LHR or USDF HID, must complete a USDF Competition Affidavit Form and pay the \$5 affidavit filing fee. A copy of a completed affidavit form from another competition may also be used for verification purposes for up to 60 days. (Exception: Affidavits cannot be used at Great American Insurance Group/USDF Regional Dressage Championships.)

#### Exceptions:

- Horses competing only in Individual Breed Classes (IBCs) at DSHB competitions, sires and dams of horses in DSHB group classes, where those sires or dams are not actually competing in the same competition, horses competing only in breed restricted dressage or DSHB classes at Regular Competitions (e.g. all Arabian, all Friesian, or all Morgan classes), or in USDF Introductory Level tests, pas de deux or quadrille, are exempt from this requirement. Also exempt are horses ridden in leadline, exhibitions, games and races, classes for 4-H members, walk-trot, academy, and opportunity classes.
- Riders and owners/lessees competing only in classes which are exempt from the USDF HID requirements are also exempt from the USDF NM identification number and NM fee requirements. Also exempt are handlers of horses competing in DSHB In-Hand or Group classes.

#### Memberships Defined

**Participating Membership (PM):** A membership issued to an individual directly by USDF. The membership year is December 1 through November 30. PMs are available for 1-year (\$100), 5-years (\$400), or life (\$2,000). A USDF Youth Participating Membership (YPM) is available for individuals who have not reached their 21<sup>st</sup> birthday by December 1 of the current membership year (\$80). A PM allows the member to compete at USEF-licensed/USDF-recognized competitions and to participate as a rider and/or owner/lessee for all Adequan®/USDF Year-End Awards and the Great American Insurance Group/USDF Regional Dressage Championship program.

**Group Membership (GM):** A membership issued to an individual by USDF when the member name and dues are submitted to USDF through an affiliate Group Member Organization (GMO). The GM year begins December 1 and ends November 30. A GM allows the member to compete at USEF-licensed/USDF-recognized competitions and participate in the USDF Rider Awards Program.

**Business Membership (BM):** A membership that runs December 1 through November 30 and is issued to a business or organization directly by USDF. The USDF BM (\$280) offers a wider variety of advertising benefits. BMs satisfy requirements of horse ownership only.

**Non-Member (NM) Identification Number:** For each USDF NM owner/lessee and USDF NM rider there will be a USDF NM fee of \$55 per competition that must be collected by the show secretary and submitted to USDF, along with the USDF Report of Fees document and the \$5 affidavit fee and Competition Affidavit Form if the person cannot provide a copy of their USDF NM card. Owners/lessees or riders exempt from the NM number requirements are also exempt from paying the USDF NM fee. If there are multiple owners of a horse and all are NMs, only one of the owners must pay the NM fee. If the horse has at least one owner who is a current USDF PM, GM, or BM there is no NM fee assessed. Competition management will be invoiced for all applicable USDF NM fees not received with the USDF post-competition paperwork, along with a report listing all USDF NMs. Competition management is then required to submit the NM fees within 30 days to the USDF. An individual with a USDF NM identification number is not eligible for any USDF membership benefits. Once a USDF NM number has been assigned, a USDF NM card can be obtained from the USDF website.

**Horse Identification (HID) Number:** A one-time tracking number for horses (\$45). Scores earned by a horse with an HID number will be recorded but will NOT be counted towards Adequan®/USDF Year-End Awards. A horse with an HID number is not eligible to compete in Great American Insurance Group/USDF Regional qualifying or championship classes. An HID number can be upgraded to a Lifetime Horse Registration (LHR) for a fee of \$95. If a horse has a USDF LHR it does not need an HID number. An HID number is a one-time fee that does not need to be renewed.

**Lifetime Horse Registration (LHR):** A horse with an LHR (\$140) is eligible for Adequan®/USDF Year-End Awards, and eligible to compete in Great American Insurance Group/USDF Regional qualifying and championship classes, assuming requirements for the owner and rider are met. If a horse has an LHR it does not need an HID number. An LHR does not need to be renewed.

Applications for USDF Participating Membership (PM), Business Membership (BM), Horse Identification (HID) number, and Lifetime Horse Registration (LHR) may be found in the following locations:

## 2026 Great American Insurance Group/USDF Regional Dressage Championships

A single Regional Dressage Championship program organized by the United States Dressage Federation (USDF), and recognized by the United States Equestrian Federation, Inc. (USEF), will be held in each of the nine USDF regions. In addition, Alaska and Hawaii may each hold state championships if an official request from a Group Member Organization (GMO) is received by April 1 of the prior year. The Regional Championship Program Rules can be found on the USDF website at [www.usdf.org](http://www.usdf.org). Please refer to the 2026 USDF Member Guide for the comprehensive list of rules and requirements for this program.

### Membership/Registration Requirements for Qualifying and Championships

*All memberships and registrations/recordings must be correct and current at the time qualifying scores are earned and at the time of the championships.*

#### Rider:

- Must have a USDF Participating\* Membership (PM).
- Must have a USEF membership (Active or Life).

#### Horse:

- Must have a USDF Lifetime Horse Registration (LHR).
- Must have a USEF (Annual or Lifetime) Horse Recording.
- USDF horse registration and USEF horse recording must be in the name(s) of the current owner(s) or lessee(s).  
A horse is not required to have breed registry papers.
- Horses must be entered in qualifying and championship classes under their official recorded names and ownership as specified in USEF GR1102.3, and transfers of ownership or lease registrations must be completed in compliance with USEF rules GR1105 and GR1108 prior to the competition in order for the horse to compete under the name of the new owner or lessee. (USEF DR127.2)

#### Owner:

- Must have a USDF Participating or Business Membership and a USEF membership (Active or Life Membership or Annual Recorded Farm/Business (with Senior Active Competing Farm Owner in good standing)). If the horse has more than one owner, at least one owner must have both active USEF membership and active USDF Participating or Business Membership and must be the owner of record with USEF and USDF. For a business or farm to be the valid owner under this requirement, it must be listed as an owner of the horse with both USEF and USDF.

\* PMs are USDF members who join USDF directly. USDF Group Members (GM) are ineligible.

**Minimum Qualifying Scores:** One set of nationally-standardized qualifying scores has been established for all USEF/USDF Regional Championships, for Training Level through Grand Prix, in three divisions: open, adult amateur and junior/young rider.

## Regional Adult Amateur Equitation Program

The USDF Regional Adult Amateur Equitation Program recognizes adult amateurs competing in equitation and promotes correct seat, position, and use of the aids in dressage. An Adult Amateur Equitation Regional Final class presented by Big Dee's Tack and Vet Supply will be held in conjunction with each of the nine USDF Regional Dressage Championship competitions, providing adult amateurs with additional opportunity for recognition. Ribbons awarded through 8<sup>th</sup> Place and gift certificates awarded to top four riders.

Adult amateurs wishing to qualify to compete in an Adult Amateur Equitation Regional Final may do so by meeting the following requirements.

### Qualifying Requirements

To be eligible for the USDF Adult Amateur Equitation Regional Final class, rider must have

- a) Earned a score of 70% or higher in any dressage seat equitation class (except walk/trot) at a USEF-licensed/USDF-recognized Dressage competition within the qualifying period of the applicable regional championship.
- or*
- b) Qualified to compete in any regional dressage championship class (excluding freestyles).

### Membership Requirements

- Rider must have a USDF Participating Membership at the time the qualifying score is earned, and at the time of the Regional Final class.
- Rider must be an adult amateur, in accordance with GR1306 of the USEF rules, and be designated with USEF as an adult amateur when the score is earned, and at the time of the Regional Final class.
- Owner must have a USDF Participating or Business Membership when the qualifying score is earned, and at the time of the Regional Final class.
- Horse must have a USDF Lifetime Horse Registration when the qualifying score is earned, and at the time of the Regional Final class.
