Check-in & Check-out

Arrival and Departure Procedures for RVs



Check-in begins at 1 p.m. and check-out time is 11 a.m. Early arrivals or late departures require prior approval. Only registered RVs and vehicles are permitted onsite to maintain a clean and organized environment for all guests.

You will be given a personalized gate code to allow your access to the facility during your stay.

RV Space Rules include parking only in assigned spaces, not blocking roads or gates, and allowing one RV per assigned space unless approved. Tents or temporary structures are not allowed without permission, and guests must maintain a clean and organized campsite.

RELEASE OF LIABILITY, ASSUMPTION OF RISK, WAIVER, AND INDEMNIFICATION AGREEMENT

RV Space Rental | 2026 California Mid-State Fair

THIS DOCUMENT WAIVES IMPORTANT LEGAL RIGHTS. READ IT CAREFULLY BEFORE SIGNING.

1. Consideration & Acknowledgment of Risk - In consideration for being permitted to use an RV parking space at Paso Robles Horse Park (the "Park") in connection with the 2026 California Mid-State Fair, I, the undersigned, acknowledge and agree as follows:

- I understand and acknowledge that RV parking and camping activities at the Park involve inherent risks, including but not limited to: personal injury, illness (including communicable diseases), property damage, theft, loss, fire, electrical hazards, utility failures, animal interactions, and the actions or negligence of other guests, exhibitors, and third parties.
- I represent that I am capable of safely operating and occupying my RV or rented travel trailer, and that I will comply with all rules, regulations, and policies of Paso Robles Horse Park, LLC ("PRHP") and any applicable local ordinances, including those outlined in the 2026 RV Welcome Packet.

2. Waiver and Release of Liability - To the fullest extent permitted by law, I voluntarily release, waive, and discharge the Park, Paso Robles Horse Park Foundation, PRHP, and their respective officers, directors, managers, employees, agents, volunteers, affiliated organizations, insurers, sponsors, and vendors (collectively, the "Released Parties") from any and all claims, demands, causes of action, liabilities, costs, or expenses, including attorney's fees, arising out of or related to:

- Any injury, death, property damage, theft, or loss that I, my family members, guests, pets, or animals may suffer while on the Park property;
- Any damage to or malfunction of my RV, vehicle, equipment, or personal property while onsite; and
- Any claims arising from electrical hookup use, utility services, or amenities provided at the RV space, whether caused by the negligence of the Released Parties or otherwise.

3. Express Assumption of Risk - I voluntarily assume all risks of injury, death, and property damage associated with my use of the RV parking space and my presence on the Park property, including risks that may arise from the negligence of the Released Parties, the actions of other guests or animals, equipment failures, weather, or other unforeseen circumstances.

4. Indemnification and Hold Harmless - I agree to indemnify, defend, and hold harmless the Released Parties from any claims, damages, liabilities, costs, or expenses (including attorney's fees) arising from:

- Any injury, death, or property damage caused by me, my family members, guests, pets, or animals while at the Park;
- Any claims brought by third parties against the Released Parties due to my actions or the actions of those in my party; and
- Any failure on my part to comply with Park rules, the 2026 RV Welcome Packet policies, or applicable laws and regulations.

5. Waiver of Unknown Claims (California Civil Code § 1542) - I expressly waive any rights under California Civil Code § 1542, which states: "A general release does not extend to claims that the creditor or releasing party does not know or suspect to exist in his or her favor at the time of executing the release and that, if known by him or her, would have materially affected his or her settlement with the debtor or released party." I acknowledge that I understand the significance of this waiver and that I am giving up any potential future claims that I may not presently be aware of, including those related to my RV space rental and stay at the Park.

6. Scope & Binding Effect - This agreement is binding upon me, my heirs, assigns, legal representatives, and any minors for whom I am signing as a parent or legal guardian. If any provision of this agreement is held invalid or unenforceable, the remainder shall remain in full force and effect. This release covers the entirety of my RV parking reservation period at the Park during the 2026 California Mid-State Fair.

7. Governing Law & Jurisdiction - This agreement shall be governed by and construed under the laws of the State of California. Any disputes arising under this agreement shall be resolved exclusively in the state or federal courts located in San Luis Obispo County, California.

ACKNOWLEDGMENT OF UNDERSTANDING - I HAVE READ THIS AGREEMENT, FULLY UNDERSTAND ITS TERMS, AND VOLUNTARILY AGREE TO BE BOUND BY THEM. I UNDERSTAND THAT BY SIGNING THIS AGREEMENT, I AM WAIVING CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE. I FURTHER CONFIRM THAT I HAVE REVIEWED THE 2026 RV WELCOME PACKET AND AGREE TO ABIDE BY ALL PARK RULES AND POLICIES.
