2026 Stall Reservation Policy for Paso Park-Managed Horse Shows

Stall requests can be made by trainers or by independent riders. By completing the online form, texting 805-369-1323 or emailing stalls@pasorobleshorsepark.com to request stalls, you acknowledge that you accept the full financial responsibility of the reservations you make on your behalf individually, or on the behalf of yourself and your training clients. We strongly advise that initial reservations be completed on the stall reservation form at pasorobleshorsepark.com/stall-reservations/. Updates can be made to your reservation at any point prior to the stall confirmation deadline by texting (805) 369-1323 or by emailing stalls@pasorobleshorsepark.com.

As soon as possible, you will be notified by Park staff if your reservation can be accommodated or if you are on a waitlist for that show. The following outlines your financial commitment and fees related to stall reservations:

- Prior to the posted **Closing Date**: No financial penalties for reducing or canceling your total stall reservation.
- After entry **Closing Date**: You are financially responsible for the full cost of the total number of stalls most recently requested and a \$50 office fee per stall reserved.

In the case that there are still stalls available after the related Closing Date of a horse show, late reservations may be made by texting 805-369-1323 or by emailing stalls@pasorobleshorsepark.com. All late reservations must include a firm stall count and will have 48 hours after sending that count to make final adjustments, after that point you will fall into the financial commitments outlined above.

If your stall needs to change after that deadline you may work with other trainers to take those stalls, HOWEVER:

- Exchanges of stalls between trainers must be communicated to the Paso Park staff in writing for final approval and must include both trainers on the communication.
- Any exchanges made between trainers less than 10 days before the start of the show may not be accounted for in the stall chart.
- If there is any misunderstanding between trainers as to who is responsible for the stall cost, it will be the trainer that had them originally reserved that is ultimately financially responsible for the stalls.

If something does change please don't hesitate to reach out to us as soon as possible. In the case of a serious medical incident, a doctor's note or veterinarian's note received via email at least 48 hours in advance of the first day of scheduled competition will result in waiving the stall fees; however, the \$50 office fee will still be due. The above language outlines the policy we follow, but with advanced notice, we will always try to work with trainers as best we can while maintaining a fair approach for all competitors.

REFUNDS

In the case that you will no longer be able to attend the horse show, please refer to the chart below to determine if you owe any outstanding fees or will be receiving any refunds.

We appreciate your efforts to help us be organized in preparing for the shows and allowing us to accommodate as many competitors as possible. Should an unforeseen circumstance arise, please do not hesitate to reach out to management to discuss the details and determine if an exception can be made.

Entries made after 8 a.m. the day prior to warm-ups (Thursday) will incur a \$100 office fee.

SHOW FEES

Stall Fee: \$95/stall

- Stall fee covers Friday-Sunday, whether for use as a horse stall, tack room, or grooming stall.
- A fee of \$25 for every stall in the barn will be charged for any barns arriving before Friday or departing after Sunday. Early arrival and/or late departure may be allowed only with written permission from management. Early arrival access begins at 12 p.m. Thursday and late departures must leave by 12 p.m. Monday.
- Stalls are restricted to 200 onsite stalls. No haul-ins are permitted. Every horse on the grounds will receive a stall fee. No sharing stalls.

RV Spot: \$150 + 14.5% in T.O.T. & assessments for full weekend (Friday - Sunday). RVs arriving early, or departing late will be charged an additional \$25.

On-Site RV Policy: On-site RV/travel trailer sites are available for reservation on a first come, first served basis. Please complete the online form at: www.PasoRoblesHorsePark.com/Stall-Reservations or call or text 805-369-1323 to make your reservations. Please see the reservation policy on page 5 for cancellation details. Hookups include 30 amp and 50 amp power, and potable water. No pump-outs are offered at Schooling Shows. Each site is assigned, you can find your assignment posted on the Stall Chart board on-site.

RV Drop-Offs and Storage: Pending availability, arrangements can be made to drop off early or pick up late RV trailers. There is a \$50 fee for up to two weeks and \$100 per month for longer between-show storage. This is for a parking spot in the trailer parking lot without hookups. The Paso Park is not responsible for the security of these trailers or any damage during storage.

Hunter/Jumper Class Fee: \$20 per class

Dressage Test Fee: \$40-\$50 per test

CA Drug Fee: \$14 per horse

Late Entry Fee: \$50 per entry if submitted after entry closing date. Entries made after 8 a.m. the day prior to warm-ups (Thursday) will be charged a \$100 office fee.

Friday Ticketed Warm-Ups: \$10 per three-minute round

Unjudged Progressive Height Warm-Ups: \$10 per warm-up

Back Gate Add/Scratch: \$10 per class

Show Scratch Fee: \$50 per horse

Non-Competing Horse Fee: \$50 - Must be approved by management prior to arrival

Haul-In Option: \$95 - While we don't allow haul-ins, we have worked to keep our stall fees at a rate that is comparable to most shows' total haul-in + facility fee. The \$95 stall fee allows you to come and go as needed and provides a safe and organized place to prepare for your ride.

RULES & REGULATIONS

The following rules and regulations will be enforced throughout the duration of the show and apply to all competitors and riders on the property:

SHOW OFFICE

Adds & Scratches: Adds and scratches may be made onsite at the show as long as they are completed prior to the start of the related class. Adds and scratches may be made at the back gate of the ring running the class on Saturdays only. Classes scratched at the horse show office prior to the start of the class will receive a full refund. Adds or scratches made at the back gate will be charged a \$10/class office fee. Classes that are not scratched will be charged at full price. It is the responsibility of the rider and trainer to ensure the classes entered are correct. Same day Dressage Adds/Scratches are not permitted.

Class Fees: Classes will be charged at \$20/class. Dressage tests range from \$40-\$50/test. The leadline and warm-ups classes are exceptions.

Credits/Balances: Competitors may be notified of any previous credits or balances from previous Paso Park activity at the time of check-in. Outstanding balances must be paid prior to picking up show numbers. Outstanding balances may be deducted from prize money payments. Outstanding balances may prevent a trainer's eligibility to reserve stalls. Competitors that fail to submit a valid form of payment for the full amount of their show bill by 5 pm on Sunday of the show week will be charged a \$50 office fee. If a balance remains unpaid for more than 30 days the office may require a \$500 deposit payment prior to processing future entries.

Discrepancies and/or Billing Errors: The show office is open and available until the completion of the last class on Sunday. If after "closing out" with the office a billing discrepancy is noted, competitors have 72 hours after the end of the show to send email communication to office@pasorobleshorsepark.com to begin rectifying the issue. After that point, any billing not in open discussion will be final.

Dues & Memberships: No dues or membership fees are required.

Early Arrivals: Those traveling from farther away may request an early arrival to be granted at management's discretion. Early arrivals open on Thursday at noon. Early arrivals or late departures will be charged \$25 per stall per night.

Entries: Entries received or postmarked after the entry close date, including those made on the days of the show, will be charged a \$50/horse late fee. No dressage late entries will be accepted after 5 p.m. the Thursday prior to competition start.

Open Balances: Competitors who do not come into the office to close out at the end of the show forfeit the right to make adjustments on any show charges. Final balances will be automatically charged to the payment method on file.

Payment: All payments should be paid by credit card, cash, or check made payable to Paso Robles Horse Park Foundation. Any checks returned by the bank will be charged a \$50 penalty, or 10% of the face value, whichever is greater. Payments made by check or cash will receive a \$10 voucher for credit towards Paso Park Merchandise. No credit card fees.

Refunds: At management's discretion, entry fees will be refunded in full, less a \$50 office charge, with a veterinary certificate or medical doctor's note submitted at least 48 hours prior to the start of the show's first judged class. Please refer to the refund information on page 6 to determine if you are eligible for a refund.

Schedule: The schedule indicated in this prize list is tentative. Based on entry numbers and other real-time factors, schedules may be updated at any time leading up to the show. The most accurate estimated schedule is posted by 8 pm at PasoRoblesHorsePark.com/daily-show-schedule the day prior. Any rounds not complete by 10 minutes before the posted time of the following class/activity may potentially receive a two-minute gate call and not have the opportunity to compete.

Trainer Splits: Trainers may choose to add tack/grooming, feed and bedding orders, RV reservations, competitor show expenses, or any other miscellaneous show purchases to their "trainer splits." Trainers have until Noon Saturday of the show to complete the trainer split form indicating which competitor accounts to apply the division of expenses to and how to apply the division. If they do not complete this form by the deadline, the office may charge the full amount to the trainer's payment on file. It is fully and solely the trainer's responsibility to indicate what items are applicable to the split and how it should be applied. By completing and submitting your entry form with the indicated trainer's name on it, you accept the responsibility to be financially responsible for any assigned splits from that trainer for all costs related to the show you are entering. The horse show management is not able to intervene in a trainer's direction of how to assign those expenses.

Vaccinations and Horse Health: The Paso Park follows USEF GR845 Equine Vaccination Rule at all equine events. Horses entering the grounds must be accompanied by documentation of Equine Influenza Virus and Equine Herpes Virus (Rhinopneumonitis) vaccinations within six months prior to entering the stables. Horses not in compliance with this rule may be required to leave the competition grounds upon request by Competition Management. Competitors may be asked to provide proof of vaccination upon check-in or prior to entering the property. All horses on the facility must have their temperature monitored twice daily for the 72 hours prior to their arrival and throughout the duration of their stay at the Paso Park. Any horse exhibiting a temperature over 101.5 F must be reported to management immediately.

COMPETITION

Awards and Prizes: Ribbons will be awarded in all classes 1st - 6th. Prizes will be available to 1st in each class. There will be a special prize for Dressage High Score. Ribbons and prizes can be collected at Celebration Station.

Class Splits: At the discretion of the judge or show management, a class may be split into multiple sections. In the case of flat classes, each section will be admitted separately by the back gate or split once in the ring by the judge. In the case of classes over fences, a "California Split" may be used to award multiple sets of placings.

Competition Attire: All riders must be in appropriate attire, which consists of a hunt coat, a shirt with collar, breeches, and tall boots, or boots and half chaps or jodhpurs.

General Comment on Attire: The hunter/jumper and dressage sports are based in tradition. We ask that as you make decisions related to attire and equipment you take this into consideration. Management reserves the right to disqualify any competitor from being judged or riding if a lack of consideration for appropriate attire seems apparent.

Draw lines: No draw lines allowed in the show ring or to school over fences.

Dressage Equipment: Standard guidelines for dressage equipment apply. The use of draw reins, side reins, neck stretchers, or other such training devices is strongly discouraged from being used in the show ring.

Equitation Equipment: Horses shown in equitation classes must have the proper equipment. Equipment requirements include: if a martingale is used, only a standing martingale is permitted, no figure-eight or dropped nosebands, and either no horse boots or leather equitation boots. No martingales are allowed in flat classes.

Helmets: All professionals and non-professionals riding on the Paso Park property must wear securely fastened protective headgear, which meets ASTM/SEI standards and carries the SEI tag. Any rider violating this rule at any time will immediately be prohibited from further riding until such headgear is properly in place.

Hunter Equipment: Horses shown in hunter classes must have the proper equipment. Equipment requirements include: if a martingale is used, only a standing martingale is permitted, no figure-eight or dropped nosebands, and no horse boots. No martingales are allowed in flat classes.

Jumper Equipment: Horses shown in jumper classes must have the proper equipment. Equipment requirements include: if a martingale is used, a standing, running, or German martingale is permitted; at 1.20m and above only running martingales are permitted. USEF-approved horse boots are permitted on both front and hind.

Lunging: Lunging in the designated lunging areas will be permitted on Friday between Noon and 6 p.m., and again on Saturday and Sunday, during daylight hours. Any lunging taking place in the GGT warm-up or competition arenas will result in a \$500 fine.

Management Rights: Management reserves the right to refuse, accept conditionally, or cancel entries, awards, or prizes, and/or adjust the time schedule, combine, scratch, or move classes as necessary without claims or damage. A two-minute gate call may be requested and enforced. All judge's decisions are final.

Non-Comp/Hor Concours Rounds: Permitted only at manager's discretion. Rounds will be charged at \$20/round.

Non-Competing Horses: Due to limited availability at these shows, all horses on the grounds must be competing. If circumstances allow and non-competing horses are permitted with management's permission, a non-showing fee of \$50 per horse will apply. To be considered a competing horse, an entry must be shown in a judged class.

Professionals: Professionals may only ride in open division classes. Any professionals riding in classes designated for Jr/Am will be disqualified for the remainder of the day.

Remount: Riders are not allowed to mount or remount their horse from within the show ring for any reason during competition.

Schooling: No juniors or amateurs are allowed to school over fences without their trainer in the area.

Trainers: No trainers are allowed on foot in the show ring during competition.

Warm-Ups: \$10 warm-up rounds will be available on Friday. Rounds are three (3) minutes long. Additionally, a \$10 warm-up class will be offered Saturday in each ring in a progressive height format. These classes will utilize set courses. Please note, warm-up closing times will be posted at back gates and strictly enforced.

FACILITY

Cell Phones: Active use of cell phones or cellular transmission devices is not permitted in any competition or warm-up arena.

Dogs: All dogs must be on a leash. Owners are subject to a \$50 fine for any dog not on a leash or for owners who do not pick up after their dog.

Feed & Shavings: The Paso Robles Horse Park Feed Office will be open during show dates and will be offering hay and shavings. Alfalfa, orchard, timothy hay, and bagged shavings will be available. For advance orders please email feed@pasorobleshorsepark.com or complete the form found under the [Competitor Resources](#) page on the Paso Park website. Orders can be made at the show in the office. Competitors may bring their own feed and bedding but they may not receive a feed or bedding delivery from an outside company.

Haul-Ins: While we don't allow haul-ins, we have worked to keep our stall fees at a rate that is comparable to most shows' total haul-in + facility fee. The \$95 stall fee allows you to come and go as needed and provides a safe, organized place to prepare for your ride.

Photo and Video Consent: By competing at or attending competitions or events at the Paso Robles Horse Park, you grant permission to the unrestricted rights to use photographs and/or video footage of yourself, your family, your guests, and/or your animal for the purpose of promotion of the Paso Park in various mediums.

Private Facility: This is a privately owned and operated facility. Any horse on the grounds must be associated with and entered into the current competition taking place. Cases of exception, including utilizing the facility to transfer shipping horses, must be approved through show management.

RV Parking & Hookups: 52 RV parking spots with water and power hookups are available for rental. A flat fee of \$150 will be charged. Additionally, in compliance with the City of Paso Robles, 14.5% will be collected to pay T.O.T. and tourism assessments. This will grant access to the spot beginning at noon on Friday through Sunday at the conclusion of the show. All RV reservations will be filled on a first come, first served basis. Early arrivals or late departures will be charged an additional \$25/RV space.

Stall Use: A flat fee of \$95/stall will be charged for each stall, tack room, and/or grooming stall reserved. This fee grants access to a reserved stall beginning on Friday at Noon through Sunday at the conclusion of the show. Stalls are 12'x12' and will be assigned by management.

Trailer Parking: All trailers must be parked in the designated trailer parking lot near the entrance of the Paso Park. Any trailer not parked in the correct location may have its hitch locked and may be subject to a \$50 fee.



PASO PARK DEFINITIONS

Progressive Warm-Ups: Warm-ups are offered on Saturday in each ring and tentatively offered on Sunday pending schedule availability. Each horse may add up to one un-judged warm-up round at any height. The warm-up round must be completed prior to any judged rounds at that height. You must complete the posted course.

Walk/Trot Flat: To be eligible, horse and rider must not have competed in a class over 2'0" at this show.

W/T Hunter Hack: Horses will first be worked and judged on the flat. Riders may be asked to demonstrate walk and trot gaits. Following the completion of the flat phase, riders will be directed by the judge to jump two fences set in a line. Riders may either walk or trot the jumping portion.

Hunter Hack: Horses will first be worked and judged on the flat. Riders may be asked to demonstrate walk, trot, and canter gaits. Following the completion of the flat phase, riders will be directed by the judge to jump two fences set in a line.

Hunters or Equitation Over Poles: Fences will consist of jump poles laid flat on the ground. To be eligible, rider and horse combination must not be competing in classes greater than 2'7", or .80m in height. Riders may choose to complete the course at the trot or canter.

Cross-Rail Hunters or Equitation: Fences are not to exceed 18" at the center. To be eligible, rider and horse combination must not be competing in classes greater than 2'10" or .85m in height. Both trot and canter gaits are acceptable in cross-rail classes. No combinations or oxers.

Short/Long Stirrup Hunters or Equitation: Fences are not to exceed 2'0". Horse rider combinations are not to have shown at heights above 3'0" in past competitions. No combinations or oxers.

Pre-Child/Adult Hunters or Equitation: Fences are not to exceed 2'3". This height may include oxers.

Low Child/Adult Hunters or Equitation: Fences are not to exceed 2'6".

Modified Child/Adult Hunters or Equitation: Fences are not to exceed 2'9".

Child/Adult Hunters or Equitation: Fences are not to exceed 3'0".

Hunter Derby: This class is open to all riders. This is a single-round derby with the course set at 2'3" and may feature up to four higher height options of 2'6"-2'8".

Up-and-Coming Hunters: Classes 900, 901, 902, and 903 are only open for horses 7 or younger OR with less than 365 days of training undersaddle. The flat class will be walk/trot, with an option to canter. No non-judged rounds will be permitted during these classes. A non-judged warm up is permitted directly preceding this class.

Jumper Tables: All jumper classes will be run at Table II Sec. 2 (a, b, c, or d) or optimum time unless otherwise specified. The table will be specified at the backgate on the course map.

Starter Jumpers (Jr/AM): Fences are not to exceed .60m. No oxers. Table IV, Sect. 1 – Optimum time will be utilized in all classes.

Modified Pre-Child/Adult Jumpers: Fences are not to exceed .70m. Table IV, Sect. 1 – Optimum time may be utilized.

Pre-Child/Adult Jumpers: Fences are not to exceed .80m.

Low Modified Child/Adult: Fences are not to exceed .85m.

Modified Child/Adult Jumpers: Fences are not to exceed .95m.

Low Child/Adult Jumpers: Fences are not to exceed 1.00m.

Child/Adult Jumpers: Fences are not to exceed 1.10m.

Modified Jr/Am Jumpers: Fences are not to exceed 1.15m.

Jr/Am Jumpers: Fences are not to exceed 1.20m.

Dressage Tests: 2024 USDF & 2022 USEA Dressage Tests will be used.

PASO PARK MEDALS

Lindsay Ashburn Memorial Green Rider Medal: Hosted at the Paso Park Schooling Show Series, the Paso Park Pathway Series, and other California shows, the Green Rider Medal features fences not to exceed 2'0" in height. Class is to be held over a hunter-style equitation course. A minimum of two riders must complete the course in order for the round to qualify for points. The top four riders (if available) in the class may be asked to work off at the judge's discretion. Alternatively, the course designer may choose to integrate the test(s) into the posted course. Tests may include USEF equitation tests 1-6 and 10-13. This class is open to all junior and amateur riders who have not competed at heights above 3'0". Riders may not cross enter in the Paso Park Medal. Finals of the Green Rider Medal will be held at the Turkey Trot & Jump Show. Points from shows hosting the medal between December 1, of the previous year through October 31 are eligible to qualify a rider for the Finals. Points are to be awarded as follows: 1st - 7pts, 2nd - 5pts, 3rd - 4pts, 4th - 3pts, 5th - 2pts, 6th - 1pt. Riders with 7 points or more are invited to participate in the Green Rider Medal Final. A final opportunity to qualify will be held at the Turkey Trot & Jump Show, the top six riders placing in that class will be qualified. Any rider that has previously won the Green Rider Medal Final is no longer eligible to compete.

Paso Park Medal: Hosted at the Paso Park Schooling Show Series, the Paso Park Pathway Series, and other California shows, the Paso Park Medal features fences not to exceed 2'6" in height. A minimum of two riders must complete the course in order for the round to qualify for points. The top four riders (if available) in the class may be asked to work off at the judge's discretion. Alternatively, the course designer may choose to integrate the test(s) into the posted course. Tests may include USEF equitation tests 1-17. This class may be run in either a jumper or hunter competition arena; jumper-style tack is permitted, no time allowed is to be considered. This class is open to all junior and amateur riders. Riders may not cross enter in the Lindsay Ashburn Memorial Green Rider Medal. Finals of the Paso Park Medal will be held at the Turkey Trot & Jump Show. Points from shows hosting the medal between December 1 of the previous year through October 31 of the current year or at the Turkey Trot & Jump Show are eligible to qualify a rider for the Finals. Points are to be awarded as follows: 1st - 7pts, 2nd - 5pts, 3rd - 4pts, 4th - 3pts, 5th - 2pts, 6th - 1pt. Riders with 7 points or more are invited to participate in the Paso Park Medal Final. A final opportunity to qualify will be held at the Turkey Trot & Jump Show, the top six riders placing in that class will be qualified. Any rider that has previously won the Paso Park 2'6" Medal Final is no longer eligible to compete.





CWD SAND HILL EQUESTRIAN MEDAL - 2'3"

The CWD Sand Hill Medal is a qualifying finals program hosted by Sand Hill Equestrian Events at the Woodside Show Series and now offered at the Paso Robles Horse Park Schooling Shows. This program aims to provide a fun and educational finals experience for junior and amateur riders. The final winner will receive a grand prize from CWD, all top finalists will receive prizes. Awards presentation and judge's discussion will be held for all finalists at the conclusion of the finals class. Following the awards presentation, riders have the opportunity to participate in a brief judge's Q&A and commentary session to ask for feedback and learn about the course. Time will be limited to the horse show schedule, up to 20 minutes. Riders are encouraged to ride for ribbons but are not required to participate in the judge's discussion.

Qualifying Class Specifications: Qualifying classes are offered at every WSS show (including the Fall Finale). All classes will run in a hunter/equitation style competition arena with fences not to exceed 2'3" in height. A minimum of two riders must complete the course in order for the round to qualify for points. The course designer may choose to integrate the test(s) into the posted course. Tests may include USEF equitation tests 1-16. Classes are open to Junior & Adult Amateur riders only that are not showing in any class that is 2'9" or above. Any rider who has won a ribbon in a qualifying class is invited to participate in the CWD Woodside Medal Final. Points from shows hosting the medal during the current show year at any date before the WSS Fall Finale are eligible to qualify a rider for the Finals. Any rider that has previously won the CWD Medal Final is no longer eligible to compete.

Tests: Dressage tests are offered from USDF Introductory through FEI Tests of Choice, as well as USEA Tests of Choice, Material Class (Any Age), and Dressage Seat Equitation classes. Test fees range from \$40–\$50. All tests will be ridden on a Standard (Large) Dressage Court (20 meters x 60 meters)

All tests are required to be entered by Monday of the show week, at 5:00 PM. No same-day adds or scratches are accepted.

Ride times will be posted on the Paso Robles Horse Park website on Thursday at 5pm.

Test of Choice (TOC): Competitors must email dressage@pasorobleshorsepark.com by Monday before the show with their TOC selection. The same test may be ridden twice by entering the same class number twice. The second ride may be either the same or a different test and must be clearly indicated at entry.

Cross Entering: Horses and riders are welcome to cross-enter into Hunter/Jumper classes.

Attire: ASTM-approved helmet, riding boots with a heel, and appropriate riding attire. Coats and braiding are not required.

Stall Reservations: All horses **must** be accounted for through a stall reservation by entry closing dates. Haul-ins and tacking at trailers are not permitted. Each horse will be assigned a stall for use from Friday at 12pm through Sunday.

THIS DOCUMENT WAIVES IMPORTANT LEGAL RIGHTS. READ IT CAREFULLY BEFORE SIGNING.

1. Consideration & Acknowledgment of Risk. In consideration for being permitted to participate in equestrian activities, including but not limited to competitions, training, riding, handling, and any related events at the Park, I, the undersigned, acknowledge and agree as follows:

a. I understand and acknowledge that equestrian activities are inherently dangerous and involve significant risks of serious bodily injury, illness (including communicable diseases), permanent disability, paralysis, or death to myself, my horse(s), and others. I further acknowledge that these risks include, but are not limited to, falls, collisions, unpredictable animal behavior, equipment failure, and the negligence of other participants, spectators, and event organizers.

b. I represent that I have the necessary training, experience, and physical ability to participate safely and that I will comply with all rules and regulations of the Paso Robles Horse Park Foundation (the "Foundation"), Paso Robles Horse Park, LLC ("PHRP"), and any governing equestrian bodies.

2. Waiver and Release of Liability. To the fullest extent permitted by law, I voluntarily release, waive, and discharge the Park, the Foundation, PHRP, and their respective officers, directors, managers, employees, agents, volunteers, affiliated organizations, insurers, sponsors, and vendors (collectively, the "Released Parties") from any and all claims, demands, causes of action, liabilities, costs, or expenses, including attorney's fees, arising out of or related to any injury, death, or property damage that I, my horse(s), or my guests may suffer while at the Park, whether caused by the negligence of the Released Parties or otherwise.

3. Express Assumption of Risk. I voluntarily assume all risks of injury or death for myself and my horse(s), and for property damage associated with my participation in equestrian activities at the Park, including risks that may arise from the negligence of the Released Parties.

4. Indemnification and Hold Harmless. I agree to indemnify, defend, and hold harmless the Released Parties from any claims, damages, liabilities, costs, or expenses (including attorney's fees) arising from:
a. Any injury, death, or property damage caused by me or my horse(s) while at the Park;
b. Any claims brought by third parties against the Released Parties due to my actions or the actions of my horse(s); and
c. Any failure on my part to comply with Park rules or applicable regulations.

5. Waiver of Unknown Claims (California Civil Code § 1542). I expressly waive any rights under California Civil Code § 1542, which states:

"A general release does not extend to claims that the creditor or releasing party does not know or suspect to exist in his or her favor at the time of executing the release and that, if known by him or her, would have materially affected his or her settlement with the debtor or released party."

I acknowledge that I understand the significance of this waiver and that I am giving up any potential future claims that I may not presently be aware of.

6. Scope & Binding Effect. This agreement is binding upon me, my heirs, assigns, legal representatives, and any minors for whom I am signing as a parent or legal guardian. If any provision of this agreement is held invalid, the remainder shall remain in full force and effect.
